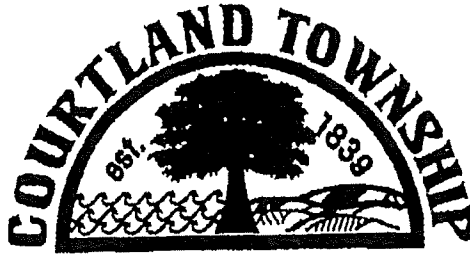

Electrical Inspections and Fees:

The permit cost for a new home is a \$35.00 application fee, \$35.00 final inspection fee, \$10.00 service fee, circuits of wiring fee, lighting fixture fee and the fees for the range, water heater, dryer, well, etc....

Remodel homes, service only inspections, pole barns, etc. – The cost for these are based on the \$35.00 application, \$35.00 final inspection fee plus any other fees that apply.

COURTLAND TOWNSHIP ENFORCES THE MICHIGAN ELECTRIC CODE

Electrical work shall not be started until the application for permit has been filled with Courtland Township. All installations shall be in conformance with the electrical code. No work shall be concealed until it has been inspected.

Expiration of Permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall be come invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of previous inspection. Cancelled permits cannot be refunded or reinstated.
